



#ILOVEFLASHWIRELESS Video Challenge 2018 (the "Challenge")

Eligible United States IBOs have the opportunity to create an original video to show their love for Flash Wireless for a chance to win a Samsung Galaxy S8.

Official Rules (VOID WHERE PROHIBITED. NO PURCHASE NECESSARY)

- 1. ELIGIBILITY:** The Challenge is open to active United States Independent Business Owners ("IBOs") who (1) are Flash Wireless, LLC ("Flash Wireless") customers, (2) register for the February 2018 ACN Charlotte International Convention ("Convention"), and (3) register for the Challenge as set forth in these Official Rules ("Eligible IBOs").
- 2. CONTEST TIMING:**
 - **Entry Submission Period:** The "Entry Submission Period" begins at 9:00 AM Eastern Time ("EST") on January 22, 2018 and ends at 11:59 PM EST on February 11, 2018.
 - **Flash Judging Period:** All Entry Videos (as defined below) will be reviewed by members of the Flash Wireless Marketing Team ("Flash Judges") to determine whether each Entry Video Qualifies under these Official Rules. The Flash Judges will then determine which of the Qualifying Entry Videos will be considered the top ten (10) Entry Videos moved forward for public voting (each, a "Finalist").
 - **Public Voting Period:** The "Public Voting Period" begins at 9:00 AM EST on February 12, 2018 and continues through 11:59 PM EST on February 15, 2018. During the Public Voting Period, the general public will have the opportunity to vote for their favorite Finalist at <http://woobox.com/yf7qdd>. Subject to the Official Rules, the Finalist with the most votes will win the Challenge.
 - **Winner Announcement:** The Challenge winner will be announced on stage at the Convention around 10:00 AM EST on February 17, 2018 (must be present to win), and will also be announced on social media on or about 1:00 PM EST on February 17, 2018.
- 3. REGISTRATION:** During the Entry Submission Period, Eligible IBOs may register for the Challenge by visiting the Compass Website and completing the Challenge registration form. Once the registration process is complete, Eligible IBOs may submit one (1) Entry Video as described herein. Each Eligible IBO who submits an Entry Video is referred to herein as a "Participant".
- 4. VIDEO SUBMISSION AND RULES:** All videos submitted in connection with the Challenge (each, an "Entry Video"), must conform to these Terms and Conditions in order to qualify for judging by the Flash Judges ("Qualify"). To be a Qualifying Entry Video, the Entry Video must (1) be posted to the Participant's Facebook page, with "#iLoveFlashWireless" in the caption, during the Entry Submission Period, (2) be original content created by the Participant, (3) have a duration of between 10 and 30 seconds, (4) show why the Eligible IBO loves Flash Wireless. Any Entry Videos that include any of the following (determined in Flash Wireless' sole discretion) will not Qualify: (a) savings guarantees; (b) price comparisons; (c) use of vendor names (i.e. Entry Videos may only use "Flash Yellow" or "Flash Green" to refer to the Flash Wireless services); (d) content that is immoral, obscene, profane, defamatory or not in keeping with the Flash Wireless image; (e) dangerous conduct, stunts or tricks that could lead to physical injury or property damage; (f) content that violates or infringes (or may infringe) on any copyright, trademark, logo or other proprietary right of any person or entity, living or deceased, including, without limitation, music or sound effects; (g) content that defames or invades the privacy or publicity rights of any person, living or deceased; (e) any person, or any person's name, image, likeness and/or voice, if Participant does not have such person's consent to include same; or (e) content that is otherwise in violation of these Official Rules. Limited to one (1) Entry Video per Eligible IBO.
- 5. JUDGING AND DETERMINATION OF WINNERS:** All Entry Videos will be screened by the Flash Wireless Marketing Department to ensure they Qualify. Qualifying Entry Videos will then be judged by the Flash Judges and the Finalists, representing the top ten (10) best Entry Videos (as determined by the Flash Judges), will be uploaded voting by the general public during the Public Voting Period at <http://woobox.com/yf7qdd>.
- 6. PUBLIC VOTING PERIOD:** During the Public Voting Period, members of the public (the "Voters") may visit <http://woobox.com/yf7qdd> to vote on the Finalists. Limit one (1) vote per Voter, per IP address. Voters will be asked to select the Finalist that best displays the participant's love for Flash Wireless. The Finalist receiving the highest number of votes will be declared the winner of the Challenge. To win, the Finalist must be present at the Convention; if a winning Finalist is not present at the Convention, the Finalist with the next highest number of votes will be named the Challenge winner. Any tie in the voting count will be broken by the Flash Judges. Only votes submitted via <http://woobox.com/yf7qdd> in accordance with these Official Rules during the Public Voting Period will be considered. Votes will not be counted if, as determined by Flash Wireless, they are (a) generated by script, macro or other automated means or any other means intended to impact the integrity of the voting process as determined by Flash Wireless; or (b) obtained by any fraudulent or inappropriate means.

- 7. NOTIFICATION AND PRIZE DETAILS:** The Finalist present at the Convention when it is announced their Entry Video received the most votes from the Voters will be the Challenge winner (the "Winner") and will receive one (1) Samsung Galaxy S8 device (the "Prize"). The Winner will be announced on stage at the Convention around 10:00 AM EST on February 17, 2018, and on social media on or about 1:00 PM EST on February 17, 2018.
- 8. MISCELLANEOUS:** (1) Employees, officers, and directors of LKN Communications, Inc. d/b/a ACN, Inc., Flash Wireless, LLC, their respective parents, subsidiaries, affiliates, advertising and promotion agencies, promotional suppliers, and each of their respective owners, employees, representatives, agents, and contractors (collectively "Contest Entities") may not participate in the Challenge. (2) Each Participant acknowledges and agrees that Flash Wireless may modify these Official Rules at any time, subject to applicable law, and that all of the decisions of Flash Wireless regarding the Challenge are final and binding. (3) Participation in the Challenge constitutes the Participant's full and unconditional agreement to and acceptance of these Official Rules, and agreement to provide to Flash Wireless any documentation or forms reasonably required in connection with the Challenge, including without limitation documents related to the licensing and use of any Entry Video. (4) Each Participant warrants that their Entry Video is an original creation of the Participant, has not been entered into any other contest, has not been previously published or won any award, and that the Participant is not aware of any conflicting rights in the submission or claims to the submission, including but not limited to copyright or other intellectual property right. (5) All taxes on the Prize and all expenses related to the Entry Video and the acceptance and use of the Prize are the sole responsibility of the Winner. (6) All Participants agree, on behalf of themselves, their successors and assigns, to release, discharge and hold harmless each of the Contest Entities from any and all injuries, liability, losses, claims, damages, costs and expenses (including reasonable attorneys' fees and court costs) of any kind resulting from the Challenge, the Participant's participation in the Challenge, or the Participant's acceptance, use or misuse of the Prize including, without limitation, personal injury, death and property damage, and claims based on publicity rights, copyright, trademark, defamation or invasion of privacy. (7) In the event that Flash Wireless determines that not enough or no eligible Entry Videos exist from which to determine Finalists or a Winner, then Flash Wireless may in its sole and exclusive discretion either suspend or terminate the Challenge or modify it (or any parts thereof) in any equitable manner that Flash Wireless deems appropriate including, without limitation, by not awarding the Prize. (8) By claiming the Prize, the Winner grants to Flash Wireless and its affiliates the right for the full period of copyright, including all extensions and renewals thereof, and thereafter in perpetuity, throughout the world, to use and re-use all or any part of the Entry Video for the purpose of making and producing promotional material and other works, publicizing and exploiting the same, by all means and in all media, whether now known or hereafter devised, and to authorize others to do so. Neither Winner nor other party now or hereafter having an interest in the Entry Video shall have any right or action against Flash Wireless, its affiliates, or any other party arising out of any use of the Entry Video or any portion thereof. (9) No Prize transfer, substitution, modification, or cash redemption permitted, except at the sole discretion of Flash Wireless. (10) In the event of any discrepancy between the English language version of these Official Rules and any other translated versions, abbreviated versions, or Challenge-related advertising or disclosures, the English language version of these Official Rules shall prevail.
